2. How We Vet Sub-processors

2.1 We select reputable providers and bind them by contract to appropriate confidentiality and data-protection obligations. Sub-processors may only process data on our instructions and to provide their service to us, consistent with our commitments to you.

3. Categories & Providers

3.1 We use sub-processors in the categories below. Specific providers may change over time; this list reflects the categories and representative providers we rely on.

- **Cloud hosting & compute** — application hosting and infrastructure — Amazon Web Services (AWS).
- **Managed database** — primary data storage — MongoDB Atlas.
- **Object storage & CDN** — file storage and media delivery — AWS S3.
- **Email & messaging** — transactional email, notifications — SMTP / email providers.
- **Push notifications** — mobile push delivery — Expo push service.

- **Payments** — payment processing — regional gateways (e.g. eSewa, Khalti).
- **AI services** — AI features and inference — foundation-model providers.
- **Analytics & monitoring** — usage analytics and reliability — privacy-respecting analytics.

4. International Transfers

4.1 Some sub-processors operate in multiple countries. Where personal data is transferred across borders, we use appropriate safeguards required by law (such as Standard Contractual Clauses), as described in our Privacy Policy .

5. Changes & Notifications

5.1 We may add or replace sub-processors as our Services evolve. Enterprise customers can request advance notice of material changes to sub-processors under their agreement, and may follow the objection process below.
